NIKAH REQUIREMENTS:

Please fill out the application in clear legible writing and email it at info@isneo.org

Please read the following requirements clearly and bring the relevant documents with you on the day of Nikah.

- Requirements:
 1. Both bride and groom must be present in person on the day of the marriage.
 2. Wali must be present in person
 - Wali must be the father unless he is deceased, if there is any issue with this please call the office to discuss
 - If wali is abroad he must give power of attorney (official letter attested by solicitor) appointing someone else to act as Wali on their behalf. Power of attorney, should clearly state name of father his passport (or ID) number, the fact that he is giving his consent for his daughter and the groom to marry.
 3. Valid Passport (or ID) for all three (groom, bride and her wali)
 4. Proof of residential address for both bride and groom.
 5. Two (2) adult male Muslim witnesses and their ID (passport or driving licence)
 6. If the bride has previously been married then she should present proof of her Islamic divorce

We do not have a fixed fee for this service. You may pay as much as you feel comfortable if the Nikah is done at ISNEO premises. However, If the Nikah is done somewhere else, the fee should include travelling and time spent.

Please note that:

If the asked requirements cannot be met, the Islamic Society of North East Ohio reserves the right to refuse to perform the Nikah.
